- D. The Applicant shall pay all service charges and fees in a timely manner, in accordance with the District's Rules and Regulations. Failure to make timely payment will result in the disconnection of water service. Water bills are due upon receipt. Late fees apply after the 15th of each month.

By signing this "Service Application and Agreement", the Applicant agrees that non-compliance with the terms of this Agreement or with the District's Rules and Regulations shall constitute denial or disconnection of water service until such time as the violation is corrected to the satisfaction of the District.
